About this framework



This framework is designed to support PIAC to measure our impact across the organisation and for individual projects.

It builds on PIAC's existing Theory of Change and 2021 – 2024 Strategic Plan. As such, it is structured around our five high-level strategies:

- Exposing injustice
- Challenging decision-makers
- Identifying solutions
- Engaging with the public and decision-makers
- Empowering people

About this framework



The framework is designed to:

- support project design, planning and critical reflection
- enable PIAC to proactively plan for and manage our impact
- use existing data collection and reporting as much as possible
- be fit for purpose to enable:
 - whole-of-organisation impact measurement
 - impact measurement for specific projects
 - profiling our work to the community

Defining impact



Impact can be defined as:

"The longer-term outcomes that are achieved from the activities, outputs and outcomes of an intervention, program, organisation or sector"

PIAC's impact measurement approach



Our approach is informed by contribution analysis - a qualitative and process-oriented approach aligned to assessing the influence of advocacy on policy outcomes:

"Advocacy occurs in dynamic political contexts, where advocates partner or work in parallel with others to advance a policy agenda...

The purpose of contribution analysis is to answer the question: In light of the multiple factors influencing a result, has the initiative made a noticeable contribution... and in what way?"

Measuring impact



We measure impact by assessing the extent to which we are achieving the short to medium term outcomes intended to contribute to the long-term outcomes in our theory of change



PIAC Theory of change statement



We build a fairer, stronger society by:

- exposing laws, policies and practices that cause or entrench injustice
- challenging decision-makers over actions that are unfair or unlawful
- identifying solutions to deliver fair, practical outcomes
- engaging the public and decision-makers to bring about change, and
- empowering people to initiate, inform and influence positive change and become leaders in social justice.
